**GUIDELINES:**

- Payments are due ~~on the 12<sup>th</sup>~~ of each month by 5:00 p.m. If the 12<sup>th</sup> should fall on a weekend or an observed holiday, payments will be due on the next business day by 5:00 p.m. Payments may be left in the overnight drop box on the 12<sup>th</sup> to avoid the 10% penalty. Any payments received after 8:00 a.m. on the next business day will have a penalty assessed. Disconnection of service is 12:00 noon ~~on the 20<sup>th</sup>~~ of each month. If the 20<sup>th</sup> should fall on a weekend or an observed holiday, disconnection will be 12:00 noon on the next business day. There will be a re-connection fee of \$50 if service has been interrupted, plus the bill with late fee.
- We provide garbage service for our customers that live within the town limits. Route pick up begins at 4:00 a.m. every Tuesday morning. Therefore, containers should be placed at curbside on Monday evening. Household garbage ONLY is to be placed within the container! Items piled on the ground will NOT be picked up. All furniture, appliances and other items of such are the customers' responsibility to be taken to the recycling center across from Heath Springs Elementary School on Solar Rd. Additional containers may be assigned for an adjusted cost.
- There is no burning of leaves, brush, trash, grass or yards allowed in the town limits.
- Neither derelict nor junk cars that do not have a current tag are allowed in the town limits. Those without current tags must be stored out of sight either in a building or covered with a defect free vehicle cover.
- By signing this application for utility service, the applicant agrees to pay all costs of collection of the applicant's unpaid bills. The Town of Heath Springs has the right pursuant to the South Carolina Debt Setoff Collection Act to collect any sum due and owed by the applicant through offset of the applicant's state income tax refund. If the Town of Heath Springs chooses to pursue debts owed by the applicant through the Setoff Debt Collection Act, the applicant agrees to pay all fees and costs incurred through the setoff process, including fees charged by the Department of Revenue, the Municipal Association of South Carolina, and the Town of Heath Springs. If the Town of Heath Springs chooses to pursue debts in a manner other than setoff, the applicant agrees to pay the costs and fees associated with the selected manner as well.
